1. Budget Workshop #5 Program Component

Jeannette Santos brought up the need of full time Social Workers.

Jeannette Santos asked about the salary \$20,000 for Adult Education Program. Dr. Kelly explained it's a starting point and it will be paid by stipend, it should be a self funding program.

Terry Fulton stated he feels we need a Human Resources Administrator. While it was discussed previously, Mr. Fulton feels the need to revisit this year to year. It is felt that there is too much additional responsibility on each existing Assistant Superintendents. Also asked, where did the budgeted salary for the Director of Technology and Assistant Superintendent for Human Resources go. The answer is it was allocated increases in contractual raises and increased health benefits.

Nate King

• Regarding the HR Director position is there a plan to evaluate the Assistant Superintendents and the effectiveness of adding the personnel responsibilities? Could the position be a Director instead of Assistant Superintendent? The personnel responsibilities spread out to the cabinet staff and these responsibilities are complex and there should be a designated person to handle these tasks.

Pastor Hayward

- The Black College Tour will that be impacted because we have money from Bethel Church, \$1,000, in the event we are cut.
- Concern about the HR and Social Worker. Just because it's in other districts doesn't mean it's good for our district.
- Dr. Kelly stated she gives her recommendations to the board and they board has the ability to make decisions.
- Pastor Hayward asked if the board has the right to change that and Mr. Fulton responded yes.

Maresa Dealy

- The previous administration was top heavy. It's fiscally responsible to reduce administrators to bring in more teachers and programs. We don't need all those people at the top, we need more at the bottom.
- Does the school board sign off on contracts? Since the answer is yes, the board should not be surprised by the contractual increases for the unions. Terry Fulton corrected her that they are discussing the administrators' increases that are not covered by a contract.
- Last year my son attended summer school in Huntington not the most convenient but thank you Dr. Kelly for providing them with buses with air conditioning. Summer school in Huntington is not the worst thing in the world. We can't do it here. We can't offer what WSBOCES does. Jeannette stated the former summer school was not our doing, it's just using our buildings, the BOCES would still run it.

Toni Bean

- What meeting did the board to vote on the increases for the administrative salaries?
- How was the budgeted money that was on the Human Resources line that was specifically redistributed, what administrators received those monies?
- Talking about funding and we know we will have less funding than in the past because of various cuts from the government, we need to look at such things as the increases in the administrative salary.
- Asked for an explanation of undesignated funding and specifically where does that money go to?
- Asked if the Building Principals have a say in the various codes for their buildings. It is not typically information shared but they Building Principals communicate to Central what their needs are and it is built into the budget.
- Wants to know how many computers and laptops may be needed.
